REPORT

Session 1: Inaugural Session on 22nd May 2017

This year's National level event for celebrating “**International Day for Biological Diversity (IDB), 2017**” was held in Goa on 22nd May 2017 at “**Dinanath Mangeshkar Auditorium**”, Kala Academy, Panaji- Goa from 09:00 am onwards. The event was organized by **The Ministry of Environment, Forest and Climate Change (MoEFCC), National Biodiversity Authority (NBA), Government of Goa** in association with **Goa State Biodiversity Board (GSBB)**. The International Day for Biological Diversity 2017 (IDB) on this year's Theme: “**Biodiversity & Sustainable Tourism**”. The event was attended by over 2000 people in two days.

Finally, she thanked the Departments for supporting the new partnership by the Global Environment Facility they are working with on access and benefit sharing which will focus on capacity building of research in academic institutions across the Country again on access to use of biological resources.

She also expressed how one needs to work on conservation, sustainable use and fair & equitable sharing of benefits related to Biodiversity and resources. She urged to the people of Goa to conserve, preserve, prosper and provide safe environment for future generations.

Shri. Manohar Parrikar, Hon'ble Chief Minister of Goa, Chairperson, GSBB unveiled the India Biodiversity Awards 2018 and launched the UNDP-GEF Global ABS Project. He also released the print material which includes NBA's Newsletter "Biodiversity Matters"; NBA's Users guide; Release of the book- "Figs of Eastern Ghats" compiled by Shri. Chandramohan Reddy from Andhra Pradesh and his team, funded by NBA; proceedings of the Biodiversity Session at the 102nd Indian Science Congress edited by Dr. S Subramaniam; proceedings of the 11th National Meet of State Biodiversity Boards held at Chennai; publication of "Biodiversity and sustainable tourism, India at Konkan and beyond" and release of National Biodiversity Target poster. Shri. Manohar Parrikar, Hon'ble Chief Minister of Goa and Chairperson of GSBB gave an insight on the issue of 'greed' overcoming 'need' and the steps needed to tackle this greed taking place in the name of tourism and economy. The society as a whole needs to cope with both tourism and biodiversity growing together suggesting a strong need for community connect and people's participation. He highlighted that though many know a lot about biodiversity but one is not totally knowledgeable about the Biodiversity act, its implications and advantages which is need of the hour. He brought the spot light on 'Dudhsagar Waterfall' and the environmental pollution associated with the said area. He quoted, "One needs to keep such areas spotless and ban plastics, stop the vehicles and ask everyone to deposit their plastic and take it back when they return." There is need of strict regulation and monitoring keeping in view the carrying capacity and sustainability of the areas of tourist attraction. Tourism needs to grow in terms of biodiversity conservation and be knowledge oriented. Thereafter, he revealed how it is baseless when the judiciary focuses on 'One square bracketed solution' for the entire Country, how it is a major problem restricting 'one law-one rule' for entire country without taking into account the diversity that exists from one state to another. And how one law – one rule regarding biodiversity does not fit the entire Nation which is multi-cultural and multi-situational.

Session 2: Technical Session

The Seminar on “**Best Practices on Sustainable Tourism**” followed the inaugural session. The seminar was chaired by **Dr. Amita Prasad, Additional Secretary, MoEFCC** and co-chaired by **Dr. B. Meenakumari, Chairperson, NBA**.



Dr. Ajit Kumar Pattnaik, IFS, Rtd, Former Principal Chief Conservator of Forest (PCCF), Odisha during the seminar on “Best Practices on Sustainable Tourism”.

The first session was taken by **Dr. Ajit Kumar Pattnaik, IFS, Rtd, Former Principal Chief Conservator of Forest (PCCF), Odisha; Member of International Steering Committee-Ramsar Center Japan; National Steering Committee- UNDP, SGP; Ministry of Forest & Environment, Member, Scientific Committee** on the topic “**Community led Conservation of Biodiversity and Sustainable Tourism- a Case Study of Chilka Lake of Orissa**”, wherein he spoke about tourism practices of Chilka lake, how the Chilka lake witnessed remarkable journey from indiscriminate poaching of birds to a responsible ecotourism site, steered by the local reformed bird hunters. He explained how the Chilka lake has amazingly emerged as one of the best site for wildlife photography and also increase in annual income. It also highly reduced the migration of villagers in search of employment. Besides it has witnessed key species conservation and lake population increase within a decade. In a nutshell, the Chilka lake transformation demonstrated with two case studies were excellent examples of how community led initiative for conservation of biodiversity can create a huge livelihood opportunity through sustainable tourism.

S.S. Kataik, IFS, Director, Great Himalayan National Park, (GHNP) presented topic on **GHNP- Biodiversity & Ecotourism**. He informed that GHNP was awarded World Heritage Natural Site Status. He also gave a simple success formula of formulating Tourism product linking Attractions, accommodation, food and drink, transport and events which transacts between Tourist needs. Through his case study he portrayed the highlights of Biodiversity, Tourism and Community advancement taking place in Great Himalayan National Park creating

opportunities of employment, restoring relationships between local community and natural environment and ultimately conserving biodiversity and environment.

Shri. Parag Rangnekar, Expert Member, GSBB made a presentation on the topic on **“Aangan Village Stay- Success story of a community based tourism enterprise”** is a community based co-operative tourism practice operating in the Verlem Village of Goa. This eco-tourism practice integrates natural beauty and daily life of rural communities promoting productive sustainable practices within its tourism offerings maintained by local initiatives and communities, distributing the benefits along with farming income supplementation keeping in view conservation of biodiversity and nature. The case study presented was not only worth appreciating but a message which needs to be adopted by others.

The first session after Post lunch was by **Shri. N. Vasudevan, Additional Principal Chief Conservator of Forests (PCCF), Mangrove Cell, Mumbai** on the topic **“Promoting Sustainable Tourism in Coastal belt of Maharashtra”** highlighting the interventions carried by Mangrove Cell, Forest Department, and Government of Maharashtra run by women for tourists to discover mangrove habitats, its associated biodiversity and familiarising with local traditions, culture and rituals in an effort to promote sustainable tourism successfully.

Shri. Gurharminder Singh, Senior Scientific Officer, Punjab State Biodiversity Board (PSBB) presented the topic on **“Biodiversity and Sustainable tourism with reference to Kaya Kalp Vriksh (Great Banyan tree) and Keshopur wetland”** and focused on the initiatives taken by Punjab Biodiversity Board for conservation and promotion of Banyan which supports the existence of a large number of key species and tried to spread a positive message ‘Caring Pays’. In his next presentation on “Conservation of 1st Community Reserve of India ‘Keshopur Wetland’ as Ecotourism site”, he elaborated on the initiatives taken to facilitate the local communities for livelihood generation to reduce their dependence on wetland resources and also site popularisation among schools and colleges for education & sightseeing.

Shri. Kingzong Bhutia, Sikkim gave a brief presentation on **“Strengthening Sikkim Himalayan Home Stays”**, where by income and employment generation opportunities are undertaken not only by sustainability but also restoration measures. Not just ban on fuel wood use, plastic bag, grazing ban but one finds complete mineral water ban in Gurudongmar lake in north Sikkim along with 80% park fees to be given to Eco-development committees.

Shri. Jigmet Takpa, IFS, Chief Conservator of Forest (Wildlife), Ladakh, Jammu & Kashmir focused on the issues and challenges associated with biodiversity conservation in Ladakh due to degradation of natural resources through competition for fodder conflicts between humans, livestock and wildlife depending on same natural resources. He revealed how the issues were tackled by identifying the opportunities for livelihood improvement by incorporating micro-level planning and vision document 2025 for conservation with the help of local communities of Ladakh.

She requested to create information if there is no information rather than giving wrong information. She said people are hungry for information and hence there is a need to make resources and information available to public not only to ponder upon but also take up responsibility. **Dr. Amita Prasad** was felicitated by **Hon'ble. Justice Bakre**, Chairperson Legal Advisory Group (LAG), GSBB.

Dr. M.K. Ramesh, National Law School of India University, Bangalore took the first session. He was introduced to the gathering by Dr. Ishwar C. Poojar, Project Manager - UNEP-GEF-MoEF ABS Programme, (NBA). Dr. M. K. Ramesh presented on the topic **“Biodiversity Act, Rules and Legal Framework for Biodiversity in India”**. He stressed that safeguarding of biodiversity forms background for systematization of legal norms. He mentioned the uniqueness of the Biodiversity laws which unlike other laws can be easily understood and practiced by all sectors of community without thorough knowledge and advice by law experts. The law not only includes horizontal (present), but also the vertical time dimensions (past and future). He said Piracy and loss of biodiversity are two main diseases experienced in the present scenario. He tried to disseminate every aspect related to Biodiversity laws. He put a limelight on Access and Benefit sharing and quoted, “Put Biological resources to use but not overuse”. He indicated that one should not go by perception but look at facts. **Dr. M. K. Ramesh** was also felicitated by **Hon’ble. Justice Bakre**, Chairperson LAG, GSBB.

Reshma Kerkar, Scientific cum Administrative Officer (SAO), GSBB**. Dr. Sanjay Molur had a very informative session which was very interactive too. He focused on five key concepts of Assessment, Networking, Capacity building and Education. He lamented that Biodiversity is often considered as low priority entity. He highlighted that

education is a key driving factor. Knowledge is the key to any kind of change spot lighting the case study of Nagaland where Kids and children are trained in identifying, documenting and analysing data of Biodiversity in their area which is done with curiosity and interest. This has not only created data base but investing in the younger generation has created lot of awareness about biodiversity conservation in practice. This practice has gone a further step where children have inculcated the habit of writing and publishing biodiversity data creating records. These are some of the successful stories for others not only to speak but follow. He finally urged the participants, NBA and State Biodiversity Board to take lead and come on board by adopting best conservation practices. **Dr. Sanjay Molur** was felicitated by **Dr. Ranbir Singh**, Principal Secretary, Environment & Forest, Govt. of Goa.

Meenakumari, expressed her concern that Taxonomists are become endangered species and there is a fall for job opportunities. She explained the ABS mechanism and components involved along with categories of ABS applications. She expressed the challenges in the way of ABS and suggested some ways forward like Interacting between SBBs & stakeholders. Awareness programs on protecting bio-resources, providing incentives for propagating bio-resources, intensifying stakeholder engagements with sector-specific training programs and monitoring, accounting ICT platforms in application procedures can be some of the few steps. She finally gave a vision of negative impacts and adopting the positive drivers for Biodiversity preservation and conservation. **Dr. B. Meenakumari** was felicitated by **Dr. Arvind Untawale**, Former Scientist, NIO.

Session IV:



Dr. Nandakumar Kamat (Environmentalism), Assistant Professor, Goa University during the seminar.

The Post lunch session was presented by **Dr. Nandakumar Kamat (Environmentalism), Assistant Professor, Goa University** spoke on “Roadmap ahead” in terms of Biodiversity, conservation and sustainable tourism. He was introduced to the gathering by **Shri. Pradip Sarmokadam, Member Secretary, GSBB**. He started his presentation with a video highlighting the dimensions of our existence as living entities. He insisted on the kinds of tourists and the kinds of visits we expect and an urgent need to first study the structure, kind

and aspects related to tourism. He posed many questions to initiate the interaction, as follows: what are Roadmaps? For whom? Who are the stakeholders and role players? Who is really interested in 'enjoying' biodiversity? He pinpointed the concept of targeting 'Biophilic tourist' and need of holistic, integrated and knowledge based roadmaps useful to BMCs. He suggested need of a series of GIS, GPS based village and town biodiversity maps illustrating local ecosystems, habitats, species and gene pools and information on Agro-biodiversity, Sacred groves etc. on which tourism products and services can be planned at micro level.

In the limelight of linking biodiversity to tourism there is an urgent requisition for policies, strategies and action plans which are ecosystem, species and genome specific. Goa lacks focused tourism and eco-tourism policies. He proposed out the 'Goa material-spiritual (GOMASPI) knowledge based model' for sustainable ecotourism. Finally, he suggested a master plan where the Government of India directs NBA to prepare National policy, Strategy Action Plan to link biodiversity to tourism along with special plan for Western Ghats. State Biodiversity Boards to prepare State level policy and plans. Microlevel BMCs to prepare community based plans for biodiversity linked sustainable tourism. Each BMC to identify and develop at least one biodiversity linked tourism product or service. All BMCs within single ecosystem could develop a common strategy and action plan and finally IT enabled and knowledge based marketing of BMC sponsored sustainable tourism plans could be implemented. **Dr. Nandakumar Kamat** was felicitated by **Dr. Antonio Mascarenhas, Former Scientist, National Institute of Oceanography (NIO), Expert Member, GSBB.**
